Dr. Stebnicki is an active teacher, researcher, and psychotherapy practitioner with over 30 years' experience working with adolescents and adults that have had exposure to extraordinary stressful and traumatic events, grief, loss, chronic illness, and disability. For over 30 years his work with both civilian and military trauma in the rehabilitation and mental health field are reflected in 8 professional texts, 28 journal articles, and over 100 presentations given regionally, statewide, and throughout the nation. He has served on many statewide and national professional counseling boards and organizations. Overall, these experiences have been cultivated and advanced in the Clinical Military Counseling Certificate (CMCC) program he developed in 2016.
